# CORESPEED FOLKSTYLE WRESTLING

1. **PERMISSION TO PARTICIPATE:** I, the parent/guardian of \_\_\_\_\_, hereby acknowledge that my child is in good general health and I give my approval for my child to participate in any and all practices and/or scrimmages of Corespeed Wrestling Club (CWC). My registration and payment for any tournaments participated by CWC will hereby be my same consent.
2. **INTENT TO INFORM:** I acknowledge that I am fully aware of the potential dangers of participation in any sport and I fully understand that participation in wrestling may result in **SERIOUS INJURIES, PARALYSIS, and PERMANENT DISABILITY AND/OR DEATH.** Furthermore, I fully acknowledge and understand that protective equipment does not prevent all participant injuries, and therefore I do hereby waive, release, absolve, indemnify, and agree to hold harmless CWC, it's governing organization, the practice facility owners, and any and all organizers, sponsors, supervisors, participants, and coaches from any claim arising out of any injury to my/or child whether the result of negligence or for any other cause.
3. **EMERGENCY MEDICAL AUTHORIZATION** I hereby grant my permission for any and all emergency medical/dental treatment and/or first aid to be administered to my child/participant, including authorizing any medical treatment facility/hospital to administer emergency treatment, for any illness/injury/accident resulting from participation in any and all CWC activities.
4. **INSURANCE DISCLOSURE:** I am aware that CWC carries group accident insurance which is considered secondary or excess for medical purposes to any and all valid insurance I possess is considered primary insurance. Furthermore, I agree to notify in writing the head coach and Team Manager, of any medical claim as a result of participation in CWC as soon as reasonable possible. I understand that any registration fee paid does not constitute a direct premium for insurance and that a deductible(s) may apply.
5. **FINANCIAL RESPONSIBILITY:** I hereby stipulate that I have been advised by CWC that the registration fee and monthly fees are **non-refundable**, along with any payments for tournament entry fees. I also am aware that my child/participant will not be refused participation based on financial hardships and could consult with the Team Manager if such hardship arises.
6. **VOLUNTEER RESPONSIBILITY:** I understand that this being a non-profit organization, I, the parent/guardian, will be required to volunteer my time to work tables at multiple tournaments and/or fundraising and fully comply with those obligations.
7. **CODE OF CONDUCT:** In order to uphold the goals of CWC and ensure that all participants have the benefit of a safe and fun learning environment, all parents, guardians, and participants of CWC practices, competitions, and banquets, must behave accordingly in a respectful, courteous and sportsmanlike manner at all times. Any adult who is using alcohol or drugs or appears intoxicated at a CWC practice or event, and/or who is flagrantly rude, attempts to intimidate, verbally abuse, heckles, taunts, ridicules, boos, throws objects and/or uses vulgarity or profane language/gestures with an official, coach, volunteer, staff member, participant or other event attendee, must receive a verbal warning and/or be asked to leave the CWC practice or event. Any adult who commits one of the above stated offenses a second time may be banned from any and all CWC practices or events for a period of one year from the date of the second offense, and their children may also be removed from the program(s) for that time period. Any adult who physically assaults an official, coach, volunteer, staff member or participant or threatens grave bodily harm will be permanently banned from any and all CWC events and the individual's children may also be permanently removed from any and all CWC programs.
8. **TOURNAMENTS:** I understand that my child must meet age and/or weight requirements as specified by the tournament upon registration of entry to that tournament. I further understand that if my child does not weight the entered weight on the day of the scheduled weigh-in of such tournament my child/participant may not compete at that tournament. Furthermore, any entry fees paid for that said tournament would be considered non-refundable. I further understand that the registration form outlining the years of experience will be used to determine the correct entry status of my child/participant (Rookie/Novice/Open) and if this is falsified my child/participant will not be allowed to compete in said tournament and there will be no refund of tournament entry fees.
